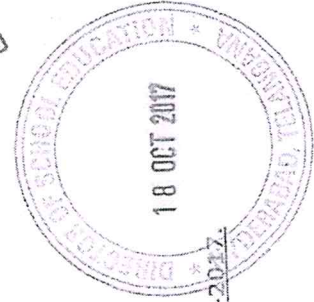

Sub:- Presidential Order - Suggestions - Requested - Reg.

2. Circular No: 11075/SPF-MC/A1/2017-2 Dt: 13.10.2017.

The Government of Telangana desires to formulate a new Presidential Order with a primary objective of protecting reservation in favour of local candidates and administrative convenience. All the Spl.Chief Secretaries, Pri.Secretaries and Secretaries to Government are requested to instruct their HoDs to have discussions with their staff and employees associations on this issue, primarily covering the following points:-

- i. Scope of Presidential Order: As on today, P.O. covers local candidate (Para 7 of P.O.), local reservation (Para 8 of P.O.), transfer and seniority for promotion (para 5 of P.O.). A suggestion has come up that the new P.O. may be restricted to recruitment only. District cadre employees Transfers can be made within Zone and the Zonal cadre transfers may be made within Multi Zone. The Multi Zonal cadre transfers up to State level.
- ii. As on today, there are two Zones and one City Cadre (for some Departments). Your suggestions are requested to indicate how many Zones can be made in the new P.O. along with the status of Hyderabad City.
- iii. There is another suggestion to include Secretariat, HoDs and State level instructions (which are under exempted category) under the purview of new P.O.
- iv. As on today the local candidate definition is based on education / residence. Your suggestions are also requested on the local candidate definition.
- v. As on today Government have issued instructions to Corporations, PSUs etc., to follow the spirit of P.O. Your feedback on status of implementation of the P.O. in the State PSUs, Corporations, Societies, and Autonomous Bodies is requested.

All the Spl. Chief Secretaries, Pri. Secretaries and Secretaries to Government are therefore requested to make it convenient to attend the meetings along with your HoDs on 23rd and 24th October, 2017 in conference hall, 3rd Floor, D - block, as per the schedule appended and bring information in the Format attached.
